

END USER LICENSE AGREEMENT

NOTICE: This is a legal Agreement between you, the "Customer" or "Partner" and Kinesix Corporation (dba Kinesix software). By, installing or using existing Kinesix developed software, the Customer agrees to be bound by the terms of this Agreement. Do not install or use existing software if you do not agree to the terms of this Agreement. If you do not agree, promptly return any software in its entirety (all copies electronic and hardcopies) to Kinesix Corporation immediately.

This Agreement constitutes the terms under which Kinesix Corporation will provide the Customer with one or more copies of Kinesix developed software including but, not limited to, the Sammi product suite, the Sendera product suite, the KX EDGE product suite, the Sammi App Server product suite and supporting utilities. Any one or more of these software components shall be called the "Software". The number of copies may be increased from time to time by Customer's Purchase Orders. Such Purchase Orders become extensions of this Agreement, and the Software which such Purchase Orders cause to be purchased shall be subject to the provisions of this Agreement. This Agreement embodies the entire contract between Kinesix Corporation and Customer and shall supersede all previous agreements, written or oral, with respect to Software to be provided under this Agreement.

GRANT OF LICENSE:

Kinesix Corporation grants to Customer the right to use each of the above-mentioned copies of the Software on a "single workstation or PC". Customer may not use one copy of the Software on more than one workstation or PC at the same time. Additionally, the Customer may not use more than one copy or instance of the software on a single workstation or PC at the same time. In short, "one license, one user" (for example, running a single Sammi component such as a Runtime on a single machine such that multiple users might potentially have access to it simultaneously is in violation of this agreement). There are no restrictions on the use of the executable code that is produced using the Kinesix Sammi API except that the executable code must interface with at least one licensed copy of one of the Kinesix Corporation software products listed above. Furthermore, in order to create an application, commonly referred to as a "Peer", by compiling and linking with the Sammi API library, a valid, purchased license is required. For example, each developer compiling and/ or linking with the Sammi API libraries (or DLLs) must have their own API license. The resulting executable is free to distribute royalty free.

COPYRIGHT:

The Software is owned by Kinesix Corporation and is protected by United States Copyright laws and international treaty provisions where necessary. Therefore, the Customer must treat the Software like any other copyrighted material except that Customer may either (a) make a copy of the Software solely for backup or archival purposes provided that Customer reproduces all Software provided to Customer, or (b) transfer the Software to a single hard disk, DVD, USB drive or any movable storage, provided Customer keeps the original solely for backup or archival purposes. The Customer may not copy the written materials, including the various electronic documents provided as part of the standard Kinesix product distribution as accompanying the Software or provided separately. If electronic documentation is received, Customer may produce one (1) copy of this documentation in hardcopy form but that hard copy is copywritten and cannot be reproduced for personal or commercial use and/or load the electronic documentation onto a single computer for viewing on multiple displays/screens. Any reproduction, duplication, or distribution of the documentation in any form, including but, not limited to electronic, magnetic, and hardcopy form, is unauthorized and prohibited.

OTHER RESTRICTIONS:

Customer may not rent or lease the Software but, Customer may transfer the Software and accompanying written materials on a permanent basis provided Customer retains no copies and the recipient agrees to the terms of this Agreement. Customer must notify Kinesix Corporation in writing of any transfer. Customer may not decompile, disassemble, or create derivative works from the Software.

GOVERNMENT LICENSE:

If Customer is acquiring the Software on behalf of any unit or agency of the United States (the "Government"), the following provisions apply:

The Government acknowledges Kinesix Corporation's representation that the Software and its documentation were developed at private expense and no part of them is in the public domain.

The Government acknowledges Kinesix Corporation's representation that the Software is "Restricted Computer Software" as that term is defined in Clause 52.227-19 of the Federal Acquisition Regulations (FAR) and is "Commercial Computer Software" as that term is defined in subpart 227.401 of the Department of Defense Federal acquisition Regulation Supplement (DFARS). The Government agrees that:

(i) if the Software is supplied to the Department of Defense (DOD), the Software is classified as "Commercial Computer Software" and the Government is acquiring only "restricted rights" to the Software and its documentation as that term is defined in Clause 52.227-7013(c)(1) of the DFARS, and

(ii) if the Software is supplied to any unit or agency of the United States Government other than DOD, the Government's rights to the Software and its documentation will be as defined in Clause 52.227-19(c)(2) of the FAR.

RESTRICTED RIGHTS LEGEND:

Use, duplication, or disclosure by the Government is subject to restriction as set forth in subparagraph (c)(1)(ii) of the Right in Technical Data and Computer Software clause of DFARS 52.227-7013.

EXPORT LAW ASSURANCES:

Customer acknowledges and agrees that the Software is subject to restrictions and controls imposed by the United States Export Administration Act (the "Act") and the regulations thereunder. Customer agrees and certifies that neither the Software nor any direct Kinesix Corporation product thereof is being or will be acquired, shipped, transferred or re-exported, directly or indirectly, into any country prohibited by the Act and the regulations thereunder or will be used for any purpose prohibited by the same.

GENERAL:

The Agreement will be governed by the laws of the State of Texas except for that body of law dealing with conflicts of law.

LIMITED WARRANTY:

To the original Customer only, Kinesix Corporation warrants for the period of ninety (90) days from the date of delivery of the Software to Customer or until the Software is modified by Customer, whichever period is shorter, that (1) The Software, unless modified by Customer, will perform substantially the functions described in the documentation provided by Kinesix Corporation, and (2) The media on which the Software is furnished will be free from defects in materials and workmanship under normal use. Customer's sole remedy under this warranty is that Kinesix Corporation will undertake to correct, within a reasonable period of time, any reported "Software Error" (failure of the Software to perform substantially the functionality described in the documentation), correct errors in the documentation, and replace any defective item with proof of purchase to Kinesix Corporation or an authorized dealer, postage prepaid, during the warranty period. If Kinesix Corporation is unable to replace defective media or if Kinesix Corporation is unable to provide corrected Software or corrected documentation within a reasonable time, Kinesix Corporation will, at its sole and exclusive option, either replace the Software with a functionally equivalent program at no charge to Customer or refund the purchase price of the Software. These are Customer's sole and exclusive remedies for any breach of warranty. Kinesix Corporation does not warrant that the Software will meet Customer's requirements, that operation of the Software will be uninterrupted or error-free, or that all Software errors will be corrected.

Kinesix Corporation is not responsible for problems caused by changes in the operating characteristic of computer hardware or computer operating systems which are made after the release of the software nor for problems in the interaction of the Software with non-Kinesix Corporation software. Kinesix Corporation will have no responsibility to replace or refund the purchase price of the media damaged by accident, abuse, or misapplication.

THE ABOVE WARRANTIES ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY KINESIX CORPORATION, ITS EMPLOYEES, DISTRIBUTORS, DEALERS OR AGENTS SHALL INCREASE THE SCOPE OF THE ABOVE WARRANTIES OR CREATE ANY NEW WARRANTIES.

SOME STATES DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO CUSTOMER. IN THAT EVENT, ANY IMPLIED WARRANTIES ARE LIMITED IN DURATION TO NINETY (90) DAYS FROM THE DATE OF DELIVERY OF THE SOFTWARE.

THIS WARRANTY GIVES THE CUSTOMER SPECIFIC LEGAL RIGHTS. YOU MAY HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE.

LIMITATIONS OF REMEDIES:

REGARDLESS OF WHETHER ANY REMEDY SET FORTH HEREIN FAILS OF ITS ESSENTIAL PURPOSE, IN NO EVENT WILL KINESIX CORPORATION BE LIABLE TO CUSTOMER FOR ANY SPECIAL, CONSEQUENTIAL, INDIRECT OR SIMILAR DAMAGES, INCLUDING ANY LOST PROFITS OR LOST DATA ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE OR ANY DATA SUPPLIED THEREWITH EVEN IF KINESIX CORPORATION OR ANY AUTHORIZED KINESIX CORPORATION DEALER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

SOME STATES DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR ACCIDENTAL OR CONSEQUENTIAL DAMAGES SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.
